LIABILITY WAIVER and RELEASE OF CLAIMS – School Year 2021-2022

Participation as a member of Walt Whitman High School Team 1389 Robotics involves physical activity and transportation and, at times, the use of tools and equipment that are potentially dangerous. Team 1389 Robotics and parent volunteers are devoted to your safety. Your safety is, in large part, dependent on your attitude and your willingness to follow Team rules and safe practices as spelled out by Team 1389 Robotics and FIRST.

This Liability Waiver and Release of Claims (the “Agreement”) is between you and your parent/guardian, and Walt Whitman High School, Montgomery County Public Schools, Board of Education members, Team 1389 Whitman Robotics Boosters, Inc., club sponsors, mentors, employees, volunteers, and students. This Agreement shall be construed and enforced in accordance with the laws of the State of Maryland.

1. You and your parent/guardian agree that whenever you are participating in Team 1389 Robotics activities you will follow all team rules and FIRST rules. You will not use any tools or equipment until you have completed the safety test and you and your parent/guardian have signed this Agreement. You and your parent/guardian will accept responsibility for damages you cause.
2. You and your parent/guardian understand that participation involves physical activity and transportation to events that could result in injury. You will report any injury immediately after it happens. You and your parent/guardian assume all risks of injury.
3. You and your parent/guardian hereby release Walt Whitman High School, Montgomery County Public Schools, Board of Education members, Team 1389 Whitman Robotics Boosters, Inc., club sponsors, mentors, employees, volunteers, and students from any and all liability for losses that may arise out of your participation in Team 1389 Robotics activities.
4. You and your parent/guardian will indemnify, hold harmless, and defend Walt Whitman High School, Montgomery County Public Schools, Board of Education members, Team 1389 Whitman Robotics Boosters, Inc., club sponsors, mentors, employees, volunteers, and students, from and against any and all medical or other claims of any nature arising out of, or in any way related to, your participation in Team 1389 Robotics during the school year 2019-2020. You and your parent/guardian agree that this waiver and release is intended to be as broad and inclusive as permitted under the laws of the State of Maryland.
5. You and your parent/guardian have read, understood and agree to the terms of this Agreement. You have discussed the contents with your parent/guardian and have the consent of

your parent/guardian to participate as a member of Team 1389 Robotics under the terms and conditions of this Agreement.
